Recommendation as submitted by Supervisors Solis and Hahn: Suspend Section 22.1 of the Rules of the Board for the limited purpose of considering this motion. Direct the Acting Chief Executive Officer and County Counsel to rename the County holiday honoring Cesar Chavez as Farmworkers Day, in alignment with recent actions by the California Legislature to acknowledge the legacy of farmworkers, address ongoing challenges, and reaffirm our commitment to their dignity and rights, beginning this year, and annually thereafter. Direct the Acting Chief Executive Officer to issue guidance to all County Departments and agencies regarding the March 30, 2026 County holiday and related events, including:

Removing the name and likeness of Cesar Chavez from all County holiday-related events, communications, and materials, and updating existing materials accordingly.
