- **3.** ECRHA Executive Director Update.
 - Kristen Aster, ECRHA Executive Director, Los Angeles County Chief Executive Office Homeless Initiative (25-3668)

Chair Nithya Raman introduced speaker Kristen Aster, ECRHA Executive Director, Los Angeles County Chief Executive Office Homeless Initiative.

Executive Director Aster informed the ECRHA BPSC Committee that their progress report was submitted to the Los Angeles County Executive Committee for Regional Homeless Alignment (ECRHA) Board at their regular meeting, which was held on June 27, 2025. Executive Director Aster reported that the ECRHA Board members appreciated the ECRHA BPSC Committee's progress and provided recommendations and feedback.

Recommendations made by the ECRHA Board Members for the ECRHA BPSC Committee included:

- Factor funding availability and fluctuations into contract decisions with regards to the standards of care.
- Ensure providers are consulted in the contract decision making process regarding standards of care and targets.
- Promote a regional approach to these standards, including funding streams beyond Measure A.
- Reduce the number of measures being proposed, given how many have been promulgated.
- As the content moves to a public forum for public reporting, make an effort to make it as easy as possible to understand the standards.
- Ensure the data produced by the standards of care process is actionable by policy makers, including exploring the possibility of oversight at the jurisdiction level.
- Address prevention and, in future standards, development work.
- Address the needs of people exiting incarceration into the standards of care.
- Engage with the Los Angeles County Affordable Housing Solutions Agency (LACAHSA) in this work.

Opportunity was given for members of the public to address the ECRHA BPSC Committee. There was no public comment on this item.

II. DISCUSSIONS/POSSIBLE ACTIONS

4. Discussion and Possible Action on BPSC Committee Implementation Timeline and Standing Coordination Processes. (25-3670)



Chair Nithya Raman introduced speakers Kristen Aster, Executive Director, ECRHA and Sarah Solon, Senior Principal, HR&A Advisors Inc.

Presenters Aster and Solon made a presentation, responded to questions, and received feedback from the ECRHA BPSC Committee.

Chair Raman expressed the importance of the ECRHA BPSC Committee answering the questions: How can we start reporting out this data? What does this data look like? And what are the meaningful jurisdictions we can get to for how this data can be reported as quickly as possible? Chair Raman informed the committee of the discussion the City of Los Angeles had with Los Angeles Homeless Services Authority (LAHSA), and observed that housing data was being received from different organizations in different formats, which required a degree of manual coordination. Chair Raman requested public reporting be tightly coordinated and consistent across all jurisdictions that are funding into the system.

During the course of discussion, it was determined that problem-solving conversations are occurring at different levels with varying representation. Chair Raman suggested that one body oversee problem-solving and coordination, and that it should be ensured that decision-makers are members of that body. It was also determined that data conversations were also occurring at different levels in different capacities. Chair Raman asked what resources are available in Measure A for data collection, management, and oversight.

Alternate Member Saba Mwine-Chang (for Member Va Lecia Adams-Kellum) asked how support for providers would be incorporated into the proposed plan, and underscored that a distinction needed to be made between performance management and support. Alternate Member Mwine-Chang also requested the creation of a list of key terms in order to make this work more accessible.

Vice-Chair Celina Alvarez stated it was important to call out equity, as the people being served have different needs.

After additional discussion regarding the goals and tasks of the ECRHA BPSC, Alternate Member Mwine-Chang indicated that LAHSA had existing key performance indicators (KPIs) and active systems management. Alternate Member Mwine-Chang also suggested engaging the research community in order to be innovative and build new knowledge.

After discussion, it was determined that that the proposed timeline, with the ECRHA BPSC Committee's incorporated suggestions and feedback, would be submitted at the next ECRHA BPSC Committee meeting for potential adoption and submission to the ECRHA Board.
