Public Comment		Other	Nathan Sudeep	<p>Hi all, my name is Nathan Sudeep, and I'm a volunteer caseworker with Project HepC Connect.</p> <p>Today, I am here to ask the Board to expand the LA County Department of Public Health's Hepatitis C budget by \$441,000 to fund 2 full-time staff positions focused on linkage-to-cure.</p> <p>Right now, more than 2 out of 3 people in LA County with HepC remain untreated, even though it's curable. I work closely with many of them, including people who are unhoused or struggling with substance use. One woman I spoke with didn't even know she tested positive – she thought her clinic would have called her. She was shocked, but relieved to hear that treatment was possible. Moments like that show how many people fall through the cracks when we don't have enough staff to follow up.</p> <p>This isn't just a medical issue; it's a public health issue. People with untreated HepC can unknowingly transmit the virus to others, including family, partners, and emergency responders.</p> <p>That is why I support the motion passed back in June 2024, which directed the Department of Public Health and the Chief Executive Office to expand staffing for HepC. But to move forward, we need dedicated County funding now.</p> <p>We have the cure for HepC. Let's make sure we have the staff to deliver it. Thank you!</p>
