REPORTS ISSUED TO COUNTY DEPARTMENTS - JUNE 4, 2025,

THROUGH JUNE 27, 2025

As you know, effective July 2017, the Auditor-Controller implemented a new process for issuing our Countywide Contract Monitoring Division's (CCMD) standard contract compliance monitoring reports. Reports are issued to the Board of Supervisors only when Priority 1 issues are reported, or when the reviews are non-routine or high profile in nature. All other CCMD reports are issued to the Director of the respective department/County affiliated organization.

From June 4, 2025, through June 27, 2025, we issued two standard contract compliance monitoring reports directly to a department with three recommendations. The two reports were of contractors providing services for the Department of Economic Opportunity (DEO). The chart below lists the two reports issued directly to the Department Director.
